# NOTIFICATION

Subject: Region-wise Service Charges for "Providing PMC services for Construction and Maintenance & Repair (M&R) works of JNVs and other Buildings"

As per Rule 133(3) of GFR 2017 "a Ministry or Department may assign repair works estimated to cost above Rupees thirty Lakhs and original works of any value to any Public Sector Undertaking set up by the Central or State Government to carry out civil or electrical works or to any other Central / State Government Organization / PSU which may be notified by the Ministry of Urban Development (MoUD) for such purpose after evaluating their financial strength and technical competence.

However, for the award of work under this sub-rule, the Ministry /Department shall ensure competition among such PSUs/ organisations. This competition shall be essentially on the lump sum service charges to be claimed for execution of works."

In compliance to above, following lowest service charges region-wise have been determined on the basis of open competitive bidding amongst eligible Central / State PSU's & notified as below shall remain valid for a period of one year from the date of issue of this notification:-

- 2. The above service charges shall be applicable on all the original works of any value and repair & maintenance (M&R) works costing above Rupees Thirty lacs.
- 3. All such Central/State PSU's who have participated in the bidding process (Bid No:01/NVS/2016-17), and considered as qualified vide NVS office order no.: 02 (002)/EE HQ-CH/2017NVS(W) dt 07.04.2017 except the lowest bidder shall be required to submit their consent for above notified service charges, for allocation of works.
- 4. All others Central/State PSU's not covered in the para 3 above, shall be required to get their eligibility ascertained as per section 4 of bid No: 01/NVS/2016-17 to be considered as qualified for allocation of works on above notified service charges.
- 5. The time limit for submission of document(s) as mentioned in point no.3 and 4 above, shall be two month from the date of issue of this notification.
- 6. NVS reserves the complete right to award the work to any eligible Construction Agency on above notified service charges.
